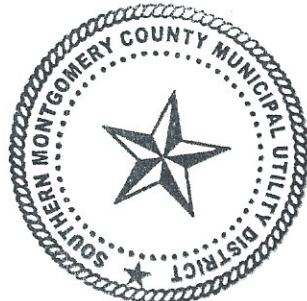
At this meeting the Board will discuss and act upon the following matters:
